MR. GRAHAM COOP

Graham is qualified as a barrister and solicitor in New Zealand and as a solicitor with higher rights of audience (Civil) in England and Wales. He advises and represents companies, governments and international organisations on international dispute resolution and public international law, with a particular focus on the energy, natural resources and infrastructure sectors, together with environmental, banking and defence issues. He also advises sovereign clients and energy companies on jurisdictional immunities issues under public international law, including in the context of judicial proceedings before European courts. His work on contentious matters has focused on the Energy Charter Treaty, investment treaties, price revisions under long-term energy sale contracts, and maritime boundary delimitation. He has appeared as counsel, advocate and expert before a wide range of international courts and tribunals, including the International Court of Justice, ICSID, the PCA and the ICC. He is on the UK Attorney General's list of public international law practitioners.

Peter is qualified as a solicitor of England and Wales. Peter has a particular focus on international arbitration, cross-border litigation and ADR. Over his career, Peter has been advisor to governments and commercial parties in connection with international disputes of a global nature in a wide range of jurisdictions around the world. He has advised clients on disputes arising in the context of cross-border contracts, BITs, the ECT, multilateral trade agreements and host State investment protection legislation. This includes significant experience in representing both investors and States in disputes arising under investment treaties and host State investment protection legislation, at ICSID, the PCA and elsewhere. His arbitration experience includes all of the established arbitral rules, including those of the ICC, LCIA, ICSID, SCC, the PCA, the Energy Charter Treaty, COMESA and SADEC.

MR. GOPAL SUBRAMANIAM **SPEAKER**

Mr. Gopal Subramaniam commenced his legal practice in 1980 in the Supreme Court of India, under the guidance of Mr. Soli J. Sorabjee, jurist & former Attorney General for India. In 1993, he was designated a Senior Advocate *suo motu* by the Supreme Court, one of the youngest to be designated in the Supreme Court's history. In 2005, Mr. Subramaniam was appointed Additional Solicitor General of India. He went on to serve as Solicitor General of India between 2009 and 2011. During his tenure as a law officer, he was honored with the National Law Day Award for

Outstanding Jurist, presented to him in 2009 by the President of India, for his consistent professional excellence and adherence to the highest traditions of the Bar. Mr. Subramaniam has also served as a member of the arbitral tribunal presided over by Justice R.S. Pathak, former Chief Justice of India and Judge, International Court of Justice in arbitration between Transammonia AG and MMTC Limited. In 2017, he represented Japan's **Daiichi Sankyo** in enforcement proceedings before the Delhi High Court for a US\$ 550 million ICC award with a seat in Singapore. Mr. Subramaniam has also appeared in several landmark cases concerning the law of arbitration in India, including the BALCO case (2012), where the Supreme Court of India ruled on the applicability of Part I of the Indian Arbitration & Conciliation Act, 1996, to arbitrations held in a foreign seat, and awards arising therefrom, and Sundaram Finance (1999).

In 2013, Mr. Subramaniam acted as a member of a Committee to Recommend Amendments to Criminal Laws (headed by Justice J.S. Verma), which recommended much-needed amendments to various Indian laws to ensure the safety and dignity of women and young children. Mr. Subramaniam, in August 2020, founded the Subramaniam Study Centre in Oxford. Located at the Prince of Wales International Centre for SANE Research, it hosts interdisciplinary research, academic, and legal work. The Centre seeks to advance the understanding of mental health disorders by "bringing together experts from a variety of fields and providing a foundation for inter-disciplinary collaboration." Mr. Subramaniam is a benefactor of Somerville College, University of Oxford, where he supports the postgraduate studies of students from India. In 2019, he was made a Foundation Fellow of the college. At Somerville, he endowed the Gopal Subramaniam Scholarships, in honor of his teacher Shri. Bharati Tirtha, which funds the postgraduate study of Indian legal policy. He also supported Somerville's choir on their tour of India in 2018. Subramaniam is a Classical Music Patron at London's Southbank Centre. Further, among his other scholarly works, Gopal Subramaniam has contributed to, and edited, **"Supreme But Not Infallible: Essays in Honour of the Supreme Court of India"**, a comprehensive work on the evaluation of the working of the Supreme Court of India, published in 2004 by the Oxford University Press.

INAUGURAL ADDRESS

PROF. (DR.) ARMIN ROSENCRANZ

Armin Rosencranz, the founding dean of the Jindal School of Environment and Sustainability, was educated at Princeton (AB - arts bachelor) and Stanford (LL.B, MA, PhD in political science). At Stanford, he had several roles, including student body president, faculty resident in an undergraduate dorm, faculty member and Stanford trustee. He taught environmental and natural resources policy and law to Stanford undergraduates for 20 years. His courses were cross-listed in ten different departments, including history, political science, human biology and earth systems. Earlier in life, Armin was a staff member of President Johnson's secret task force on government organizations. He also conducted a set of hearings on urban problems for then-Senator Robert Kennedy. He founded Pacific Environment, an international environmental NGO, in 1987, and led it for a decade. Armin also taught climate, energy and global environmental law at Boalt Hall - UC Berkeley, Golden Gate Law School and Georgetown Law School before teaching these same subjects at Jindal from 2014 onward.



PROF. (DR.) CHRISTINA VOIGT

Dr. Christina Voigt has been Co-Chair of the Paris Agreement's Implementation and Compliance Committee (since June 2020), Facilitator of negotiations on the procedures for the compliance committee in the Paris Agreement's Rulebook, COP24, Katowice, Poland (2018, resulting in Decision 20/CMA.1), Expert Consultant for UNEP (drafting of the UN Secretary General's report: "Gaps in International Environmental Law and environment-related instruments: Towards a Global Pact for the Environment" (2018), Adviser to the Norwegian Member of the Board of the Green Climate Fund (2017), United Nations General Assembly Res. A/73/419), Facilitator of negotiations on 'entry into force' of the Paris Agreement, COP21, Paris (2015), Co-Chair for the UNFCCC COP work programme on results-based financing or REDD+ activities, COP19, Warsaw, Poland (2013) (resulting in Decision 9/CP.19), Arbitrator at the Permanent Court of Arbitration (specialized arbitrator pursuant to the optional rules for arbitration of disputes relating to natural resources and/or the environment) (since 2015) and Member of International Legal Expert Drafting Panel on "Ecocide" (<https://www.stopecocide.earth/expert-drafting-panel>).



DR. AYLIN YILDIZ

Dr. Aylin Yildiz is a research fellow at the World Trade Institute, University of Bern. Her expertise and research interests lie in climate change, human mobility, disasters and human rights. She obtained her Ph.D. from the World Trade Institute, University of Bern (Switzerland); LL.B. eq. degree from the University of Istanbul (Turkey); LL.M. degree from the University of Toronto (Canada) and LL.B. Hons. degree from LSE (UK).



PROF. (DR.) TATJANA KOCHTEKOVA

Dr Tatjana Kochteko grew up in Kyiv, Ukraine and received her first PhD from Kyiv National University in 1998 on Self in the Speech Acts Theory. After her PhD defence, she joined Professor Evert van der Zweerde's Center for Russian Studies at the University of Nijmegen in the Netherlands as a junior researcher and completed her second PhD in philosophical anthropology in 2001 (under the title "Vladimir Solovyov's theory of humanity"). In the same year, she was appointed as a Postdoctoral Associate in environmental philosophy at Utrecht University for Humanistic. She has been appointed as a lecturer in Applied Ethics and Philosophy of Technology at Fontys University for Applied Sciences (Eindhoven) and the University of Twente (Enschede). She is the author of several books and a series of articles on applied ethics, and the philosophy of man and technology. Recently she published, together with Rico Sneller and Nelleke Canters, a book The Plurality of the Arts of Living (Garant, Belgium, 2018) and now is finalizing the draft of Homo Sapiens as a Problem, in cooperation with Sergey Kleftsov and Rico Sneller. Her research is focusing on philosophical anthropology, the art of living and the philosophy of technology. Her main topic is the new vision of the human being as a result of technological convergence (NBIC technologies). This includes the current transformation of the human condition and its implications. Her PhD at the Radboud University of Nijmegen was dedicated to the dynamics of the human condition by Vladimir Solovyov as compared to the human condition as viewed by Friedrich Nietzsche, Martin Heidegger and Ludwig Binswanger.

PROF. JOEL TRACHTMAN

Prof. Trachtman has been a professor of international law at The Fletcher School of Law and Diplomacy at Tufts University since 1989. A 1980 graduate of Harvard Law School, where he served as editor in chief of the Harvard International Law Journal, he practiced law in New York and Hong Kong for 9 years before entering academia. From 1998 to 2001, he was Academic Dean of the Fletcher School, and during 2000 and 2001, he served as Dean ad interim. Prof. Trachtman teaches courses in commercial law, including international business law, international financial law, and international trade law. He also serves as Co-Director of the Center for International Law and Governance, and as a member of the Tenure and Promotion Committee and the Academic Council.

Prof. Trachtman is a world-renowned authority on international trade law, and has pioneered the application of economic analysis of law to international law. The author of over a hundred scholarly articles and chapters, he has published 10 books, including with publishers such as Harvard, Oxford, and Cambridge University presses. He has served as a member of the boards of the leading journals in international law, including the American Journal of International Law, the European Journal of International Law, the Journal of International Economic Law, and the Singapore Yearbook of International Law. He has consulted for a number of governments and international organizations, including the United Nations, the World Bank, and the OECD. He has been a visiting professor at Basel, Hamburg, Harvard, Hong Kong, MGIMO, Pretoria, Swansea, and Hebrew University, and has lectured at other leading universities around the world. He frequently comments in the media on current international commercial law issues.

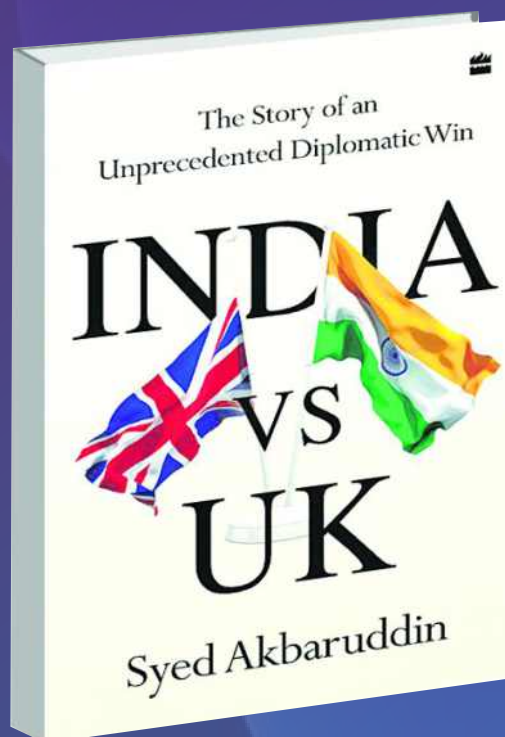

AMB. SYED AKBARUDDIN

Ambassador Syed Akbaruddin has been for long Indian diplomacy's most visible face. Recently he has joined as the Dean of the Kautilya School of Public Policy, following a distinguished diplomatic career spanning more than three decades. Ambassador Akbaruddin was a familiar public presence, during 2012-15, articulating India's foreign policy stances on a number of international issues as the Official Spokesperson of India's Ministry of External Affairs. He was also instrumental in the use of social media tools to considerably expand India's public diplomacy outreach. An experienced multilateral diplomat, Ambassador Akbaruddin was the Chief Coordinator of the milestone India-Africa Forum Summit held in October 2015 in New Delhi that strengthened India's ties with all 54 African states. He is among the few Indian diplomats who has the distinction of also serving as an international civil-servant in a United Nations entity. From 2006-11, he worked at the International Atomic Energy Agency (IAEA) in Vienna. He was the Head of the External Relations and Policy Coordination Unit and later also the Special Assistant to the Director-General of the IAEA.

Earlier, at the headquarters of the Ministry of External Affairs, he headed the Human Resources Division in 2005-06 and prior to that was the Director of the Foreign Secretary's Office in 2004-05. From 2000 to 2004 he was the Consul General of India, Jeddah in the Kingdom of Saudi Arabia and brought about many innovative changes including use of computer tools to assist the more than 100,000 Indians who performed the annual Haj pilgrimage. Having served as Counsellor at the Indian High Commission in Islamabad (1998-2000) he is well versed in key issues between India & Pakistan. Also, he has worked at the Permanent Mission of India to the United Nations as First Secretary (1995-98). He was a member of the UN's apex body, the Advisory Committee on Administrative & Budgetary Questions (ACABQ) during 1997-98. Prior to that he was First Secretary in India's Embassy in Riyadh and Second Secretary/Third Secretary in Cairo, Egypt. He is proficient in Arabic.

PROF. (AMB.) VENU RAJAMONY

A career diplomat with thirty four years of experience, scholar of international relations and former journalist, Venu Rajamony is a well known public speaker, author and patron of arts and culture. He is currently Professor of Diplomatic Practice at the Jindal Global Law School of the O.P. Jindal Global University, Sonapat, Haryana. Rajamony was Ambassador of India to the Netherlands from 2017 to 2020. He was also the Permanent Representative of India to the Organization for Prohibition of Chemical Weapons in The Hague, and responsible for India's relations with the International Court of Justice and the Permanent Court of Arbitration.

Ambassador Rajamony appeared on behalf of India before the International Court of Justice in the matter of "Advisory Opinion concerning the Legal Consequences of the Separation of the Chagos Archipelago from Mauritius." He was Member of the Indian delegation before the ICJ in the Jadhav case (India v. Pakistan) and Co-Agent of India in Enrica Lexie case (Italy v. India) before the Permanent Court of Arbitration.

PROF. (DR.) PRABHASH RANJAN

Prof. (Dr.) Prabhash Ranjan holds a PhD in law from King's College London. He studied at King's College London on a doctoral scholarship. Prabhash studied at School of Oriental and African Studies (SOAS) for LL.M on a British Chevening Scholarship. He also holds LL.B. and B.A. (Hons) in Economics degrees from University of Delhi.

Prabhash teaches and publishes in the area of international investment law and international trade law. He was working as an Associate Professor at the South Asian University – an international university established by the SAARC nations – before joining O.P. Jindal Global University. Prabhash has also worked as an Associate Professor at the National Law University Jodhpur and as Assistant Professor at the National University of Juridical Sciences, Kolkata. He has been a Visiting Scholar at Brookings India and a Visiting Fellow at the Lauterpacht Centre for International Law, Cambridge University. He was member of the team that drafted the 260th report of the Law Commission of India on the 2015 draft model Indian bilateral investment treaty. Recently he was invited by the Parliamentary committee on External Affairs to depose as an expert witness on 'India and bilateral investment treaties'.

He has authored a book, 'India and Bilateral Investment Treaties: Refusal, Acceptance, Backlash' published by Oxford University Press in 2019. Prabhash has published in several leading international journals like the Netherlands International Law Review, ICSID Review, Journal of World Trade, Journal of World Investment and Trade, Asian Journal of International Law, Cambridge International Law Journal, George Washington International Law Review, Northwestern Journal of International Law and Business to name a few. He regularly contributes opinion editorials in India's leading national newspapers like The Hindustan Times and The Indian Express.

PROF. (DR.) ESTHER SCHMIDT

Esther Schmidt is the founding director of the Centre for Historic Houses and teaches design history, heritage studies and interior design at the Jindal School of Art & Architecture, O.P. Jindal Global University. A scholar-practitioner her expertise is the research, interior design, development and promotion of historic houses and palaces. In this capacity she has developed designs for listed buildings including UNESCO world heritage sites and created innovative contemporary uses for historic buildings. Under her leadership the Centre for

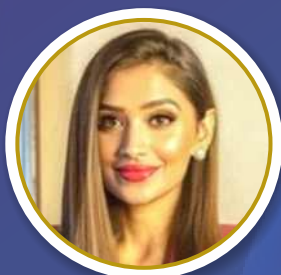
Historic Houses, established in the autumn of 2019, has become a leading institution in the heritage sector and brings together some of the brightest minds in heritage, to foster knowledge exchange between owners of historic houses, academics and heritage experts. In addition Dr. Schmidt has the vision to underscore the relevance of historic houses by addressing some of the big questions of our times from water to sustainability, poverty alleviation, education and capacity building and their general social impact on local communities. In this context she has organized the international Water & Heritage Conference in 2019 with the support of ICOMOS Netherlands and INTBAU (International Network for Traditional Building Architecture and Urbanism under his patronage HRH the Prince of Wales).



PROF. (DR.) SHRUTI JAIN

Dr. Shruti Jain is an Associate Professor at the Global Languages Centre, O.P. Jindal Global University, Sonapat, India. She completed her PhD at the Centre of German Studies, JNU, New Delhi. In her PhD thesis she dealt with the Indian reception of Friedrich Nietzsche. Her areas of interest are literary theory, German literary history, Philosophy and Indo-German cultural encounters. During her PhD, she received a DAAD scholarship to visit the Humboldt University of Berlin from 2007 to 2008. Dr. Jain has been working as a Teacher of German as a

Foreign Language since 2002. She pursued her teacher's training at Max Mueller Bhavan, Pune and at the Goethe Institutes, Berlin and Munich. She has delivered lectures at various Indian universities and published articles in the fields of Cultural Studies and Teaching German as a Foreign Language.



MS. LAKSHMI LALITA MOHAN

Lakshmi Lalita Mohan is involved in the promotion of industrial cooperation and bilateral relations – trade, foreign direct investments, joint ventures and technical collaborations between India and Germany. 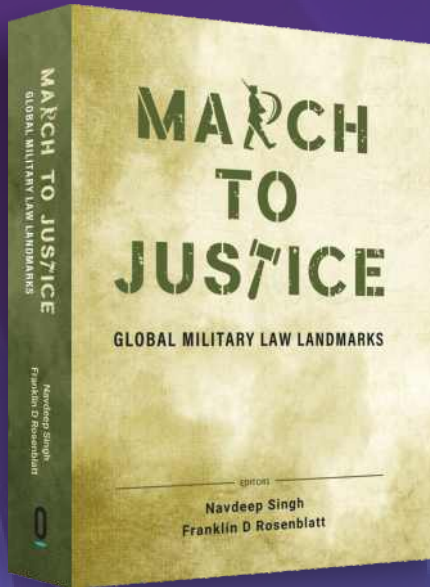

NAVDEEP SINGH

Navdeep Singh is a practising lawyer at the Punjab & Haryana High Court, Chandigarh, India. He is the founder President of the Armed Forces Tribunal Bar Association at Chandigarh. Navdeep has been a national service volunteer-reservist with the Territorial Army in the rank of Major in the past. The Territorial Army is a unique force of volunteers who, while carrying on with their civil vocations, wear the uniform for a few days in a year during their spare time in peace so that they can bear arms for the nation's defence during war and national emergencies. ROUND-TABLE DISCUSSION on EXPLORING THE REFORM PROPOSALS OF THE UNITED NATIONS

ABSTRACT

The 75th anniversary of the United Nations is an apt moment to reflect on the current status and envisage potential bold reforms to the architecture of the UN system. While political barriers to change are hard to overcome, imagining transformations can spur discussion in helpful ways and identify areas where fresh attention is needed. This paper argues that the UN Security Council's ineffectiveness in addressing arising complex security challenges, such as conflict re-escalation, climate change and COVID-19, among others, can be solved by establishing three additional Councils: a Peacebuilding Council, a Climate Security Council, and a Health Security Council. Each would focus on a specific security-related agenda, operate openly, transparently, responsibly, and without veto. The current Security Council remains the primary organ focusing entirely on Chapter VII actions in response to threats to international peace and security. The three new Councils do not undermine all privileges of the current permanent members of the Security Council, but benefit from larger, more representative configurations of Member States, amplifying their voice for world peace, which in turn brings new ideas, expertise, funds, services, and capacities to strengthen international peace and security, and engages relevant UN agencies, other organizations, and actors to ensure well-informed decisions. This innovative model aims to contribute to the debates leading up to and following the UN75, to be taken up by governments committed to multilateralism, major regional organizations, and the UN Secretary-General in the coming years. An independent expert commission should be established to study and elaborate on this proposal further.

Remembering CHIEF OF DEFENCE STAFF **GENERAL BIPIN RAWAT** & **RE-THINKING THE FUTURE OF THE ARMED FORCES**

Born in Pauri, Uttarakhand on March 16, 1958, his family had been serving in the Indian Army for multiple generations. His father Laxman Singh Rawat was from Sainj village of the Pauri Garhwal district and rose to the rank of Lt General. An alumnus of the National Defence Academy (NDA) and the Indian Military Academy (IMA), Rawat was commissioned into the Indian Army in December 1978 in the same unit as his father, the fifth battalion of 11 Gorkha Rifles. The first CDS is a veteran of counterinsurgency warfare and has served in some of the most difficult terrains of India, including the northern and eastern commands. During his 43-years in service, Rawat served as a Brigade Commander, General Officer Commanding-in-Chief (GOC-C) Southern Command, General Staff Officer Grade 2 at the Military Operations Directorate, Colonel Military Secretary and Deputy Military Secretary in the Military Secretary's Branch and Senior Instructor in the Junior Command Wing. (1989) and the School of Law « Paul Cézanne », Aix-Marseille III with LL.M. (1991) and SJD in international law (1996) summa cum laude. Motoc has a Ph.D in Philosophy from the University of Bucharest (1999). She has taught and researched at the Institute for Human Rights, Vienna (1999), University of New York (2002-2004), Yale School of Law (2003-2007), European Institute of Florence (1997), University Paris I, Sorbonne (2013), University of Strasbourg (2015), EUIC Venice. Iulia Motoc was a member (2000-2007) and President (2000-2001) of the UN Human Rights Sub-Commission on Promotion and Protection of Human Rights. She was UN Special Rapporteur for Democratic Republic of Congo, reporting crimes against humanity and war crimes (2001-2004). Iulia Motoc was UN Rapporteur of Human Rights and Genetics (2003-2007) and President of the UN Human Rights of the Administration of Justice; she was co-drafting the UN Report of free, prior and informed consent of indigenous people and UN Guidelines of Extreme Poverty. Iulia Motoc was a member of the EU Agency of Fundamental Rights (2010-2012) and Member of the Advisory Committee of the Framework Convention on Promotion and Protection on Minorities (1998-2004 and 2008-2012). Iulia Motoc has authored and edited several books, studies and articles such as "The Impact of the ECHR in democratization in Central and Eastern Europe", Cambridge, CUP (2016).

PROF. BENJAMIN MASON MEIER

Benjamin Mason Meier is a Professor of Global Health Policy at the University of North Carolina at Chapel Hill. Dr. Meier's interdisciplinary research—at the intersection global health, international law, and public policy—examines rights-based approaches to health. Working collaboratively across the University of North Carolina's Department of Public Policy and Gillings School of Global Public Health, Dr. Meier has written over one hundred articles on the development, evolution, and application of human rights in global health.

His recent global health governance volume, *Human Rights in Global Health: Rights-Based Governance in a Globalizing World* (OUP 2018), examines the influence of human rights across the health efforts of the United Nations. Drawing from this comparative analysis of international organizations, Dr. Meier has published an academic textbook for the field of health and human rights, *Foundations of Global Health & Human Rights* (OUP 2020). To advance legal scholarship on contemporary global health issues, he recently launched a quarterly column on Global Health Law in the *Journal of Law, Medicine & Ethics*.

As a contributor to the development of rights-based global health policy, Dr. Meier serves additionally as a Senior Scholar at Georgetown University's O'Neill Institute for National and Global Health Law, as the Founding Chair of the American Public Health Association's Human Rights Forum, as the Human Rights Chair of the Global Health Law Consortium, and as a consultant to international organizations, national governments, and non-governmental organizations.

Dr. Meier received his B.A. in Biochemistry from Cornell University, his J.D. and LL.M. in International and Comparative Law from Cornell Law School, and his Ph.D. in Sociomedical Sciences from Columbia University.

PROF. (DR.) CEDRIC RYNGAERT

Prof. Dr. Cedric Ryngaert (Ph.D. Leuven 2007) is Chair of Public International Law at Utrecht University (Netherlands) and Head of the Department of International and European Law of the University's Law School. His research interests relate to the law of jurisdiction, immunities, non-state actors, the role of international law before domestic courts, sanctions, international responsibility, and international organizations. Among other publications, he authored *Jurisdiction in International Law* (OUP 2015, 2nd ed) and *Selfless Intervention: The Exercise of Jurisdiction in the Common Interest* (OUP 2020). He is a member of the Dutch Advisory Council on International Law, and editor-in-chief of the *Utrecht Law Review* and the *Netherlands International Law Review*. Previously, he taught at Leuven University and the Military Academy of Belgium.



DR. SHARON MILLS

Sharon Mills recently received her Ph.D. from Utrecht University's Department of Law, Economics and Governance in the Netherlands. Her dissertation research applied a transdisciplinary approach to examine documentary evidence that illustrates the Holy See's universal moral authority activity in the United Nations. A transnational legal theory of authority was used, observed through a historical lens of the religious institution's joint spiritual-temporal rule with past empires, to ascertain the Holy See's contemporary practices and objectives in the UN. Her research conclusions indicate that the Holy See utilizes essentially the same formula for acquiring power in the UN as it has throughout history by asserting moral supremacy over governmental authority decisions. This ancient formula is fundamentally rooted in Christian primacy dogma, which is used to secure ongoing relevance in an increasingly secular and globalized world. As part of her research on authority theorization and based on accounts found in scholarship, she developed a novel classification system for identifying the characteristics found requisite in the composition of realized authority.

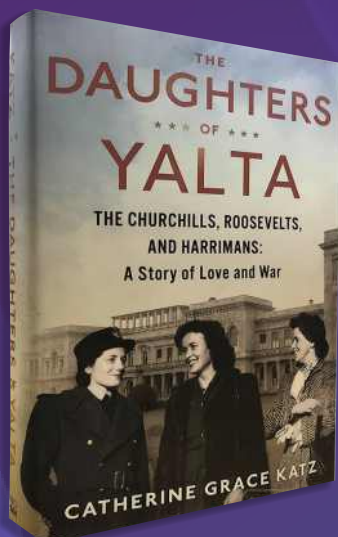

About the Lecture:

In early January, protests began in Kazakhstan over rising gas prices. The protests have transformed from mere price reduction demands into anti-government riots. Protestors were demanding, not only lower fuel prices, but also an end to widespread governmental corruption and general political liberalization. On January 5th, President Tokayev requested assistance from the Eurasian inter-governmental military alliance, the Collective Security Treaty Organization (CSTO). Russia responded quickly and sent its troops the next day. The question of whether this troop deployment complied with the law of intervention by invitation in general, and the CSTO Treaty in particular, is of concern to international lawyers. This presentation will briefly discuss the CSTO regime and the extent to which it permitted the Russian military to enter its Central Asian ally.

About the Speaker:

Julia Emtseva is a research fellow at the M.Phil and currently is a scholar in residence at New York University School of Law. Julia obtained her LL.M. in International Human Rights Law at the University of Notre Dame Law School, M.A. in Human Rights and Democratization in the Global Campus of Human Rights, and LL.B. at the American University of Central Asia. PROF. (DR.) ANTOINE DUVAL

Subtitle: Righting the *Lex Sportiva*: The Rise of Human Rights in Transnational Sports Law

This lecture will aim to walk the audience through the growing human rights critique against the regulations and decisions of international sports governing bodies (such as the IOC or FIFA). In particular, it will touch upon the human rights critique raised against mega-sporting events, the regulation of freedom of expression, and rules related to the male-female divide in sports competitions. It will as well discuss the recent decisions of the European Court of Human Rights involving sporting matters and the responses and reforms provided by the international sports governing bodies.

Antoine coordinates the research strand on advancing public interests in international and European law. He is a Senior Researcher at the Asser Instituut since February 2014 and defended his Ph.D. at the European University Institute in Florence in September 2015. His thesis dealt with the legal interaction between the *Lex Sportiva* (the private regulations governing international sports) and EU Law. PROF. RANA MITTER

Prof. Mitter works on the emergence of nationalism in modern China, both in the early twentieth century and in the present era. China has always drawn on its past to draw lessons for the contemporary political scene; he believes that to help us understand the new China, we must look at its past. He is currently Director of the University China Centre. He is the author of several books, including *Modern China: A Very Short Introduction* (2008, new ed. 2016), and the award-winning *A Bitter Revolution: China's Struggle with the Modern World* (2004). His most recent book *China's War with Japan, 1937-45: The Struggle for Survival* (US title: *Forgotten Ally*) was named as a 2013 Book of the Year in the *Financial Times* and the *Economist*, was named a 2014 CHOICE Outstanding Academic Title, and won the 2014 RUSI/Duke of Westminster's Medal for Military Literature. He presents and contributes regularly to programmes on television and radio, commenting on contemporary Chinese politics and society. Gian Luca Burci is Adjunct Professor of international law at the Graduate Institute of International and Development Studies, Geneva since 2012. Before this appointment, he served in the Legal Office of the World Health Organization from 1998 to 2016 and was its Legal Counsel from 2005 to 2016. His courses include the law of international organizations, the role of an international legal counsel and global health law. Prof. Burci holds a post graduate degree in law from the University of Genova, Italy. Prof. Burci is the co-author of the leading English book on WHO, editor of the first research collection on global health law, co-editor of the first research handbook on global health law and author of numerous articles and book chapters.

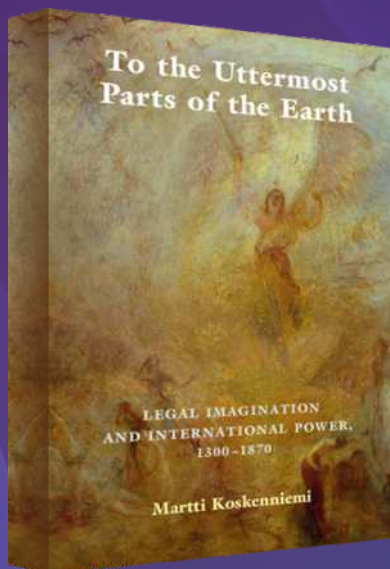

Iulia Motoc is Judge at the European Court of Human Rights since December 2013 and Professor of European and International law at the University of Bucharest. Previously she served as Judge at the Constitutional Court of Romania (2010-2013). Motoc graduated the School of Law of the University of Bucharest with LL.B. (1989) and the School of Law « Paul Cézanne », Aix-Marseille III with LL.M. (1991) and SJD in international law (1996) summa cum laude. Motoc has a Ph.D in Philosophy from the University of Bucharest (1999). She has taught and researched at the Institute for Human Rights, Vienna (1999), University of New York (2002-2004), Yale School of Law (2003-2007), European Institute of Florence (1997), University Paris I, Sorbonne (2013), University of Strasbourg (2015), EUIC Venice. Iulia Motoc was a member (2000-2007) and President (2000-2001) of the UN Human Rights Sub-Commission on Promotion and Protection of Human Rights. She was UN Special Rapporteur for Democratic Republic of Congo, reporting crimes against humanity and war crimes (2001-2004). Iulia Motoc was UN Rapporteur of Human Rights and Genetics (2003-2007) and President of the UN Human Rights of the Administration of Justice; she was co-drafting the UN Report of free, prior and informed consent of indigenous people and UN Guidelines of Extreme Poverty. Iulia Motoc was a member of the EU Agency of Fundamental Rights (2010-2012) and Member of the Advisory Committee of the Framework Convention on Promotion and Protection on Minorities (1998-2004 and 2008-2012). Iulia Motoc has authored and edited several books, studies and articles such as "The Impact of the ECHR in democratization in Central and Eastern Europe", Cambridge, CUP (2016).
